Life Event Changes

Benefits > Report a Life Event

- Qualifying life events are:
 - Marriage or divorce
 - Birth or adoption of your child
 - Death of your spouse or child
 - Your child turns 26
- You must enroll and submit supporting documentation within 31 days of the qualifying status change
- *Note: The date the status event occurred is considered the effective date*
- If you have experienced a qualifying life event, select the name of the applicable event from the Create New Life Event list
- A wizard will walk you through the change request and you will be prompted to specify the appropriate adjustments to your coverage
