The webinar is a brief introduction and overview of the Congressionally Directed Medical Research Programs (the CDMRP), with a focus on the largest program under that umbrella, the \$370-million dollar Peer Reviewed Medical Research Program (the PRMRP). The PRMRP funds research focused on 50 specified Topic Areas. One of this year's new Topic Areas is Proteomics, a foundational tool for clinical research and patient and subject management.
